NATA Foundation Research Grant Sponsor Options

The NATA Foundation offers five (5) options for consideration by the NATAFoundation research grant sponsors. The requirements for each option are outlined below.

FULL ENDOWMENT RESEARCH GRANT OPTION*

- Agree to make a one-time scholarship sponsorship contribution of \$50,000 for a Doctoral Research Grant or \$25,000 for a Masters Research Grant
- The one-time research grant sponsorship contribution of \$50,000 or \$25,000 must be received by March 31st of the calendar year during which the first grant is to be awarded.
- Your \$50,000 or \$25,000 gift will be maintained in perpetuity (in your designated research endowment account) by the NATA Foundation.
- A \$1,000 or \$2,500 research grant (depending on designation) award will be presented annually, beginning at the next NATA Clinical Symposia & AT Expo, in the name of the research grant sponsor.
- Each successive annual grant award will be funded by the earnings from the balance of your one- time gift (in your designated scholarship endowment account).
- No further research grant sponsorship contributions will be required for this option.

5-YEAR RESEARCH GRANT OPTION*

- Sign a written agreement to make at least five (5) successive annual research grantsponsorship contributions of \$10,000 or \$5,000 (depending on designation).
- Each subsequent annual research grant contribution of \$10,000 or \$5,000 will be invoiced at the beginning of the calendar year. A research grant will not be awarded until all 5 payments have been received.
 - Should you wish to have a research grant awarded in the name of the research grant sponsor prior to full funding, the NATA Foundation will invoice the research grant sponsor in the amount of \$1,000 or \$2,500 (depending on designation) under the research grant name for award at the NATA Clinical Symposia & AT Expo.
- After the full amount of \$50,000 or \$25,000 has been received, each successive annual research grant award will be funded by the earnings from the balance of 5 year contributions (in your designated research grant endowment account).
- No further research grant sponsorship contributions will be required.

ANNUAL RESEARCH GRANT SPONSORSHIP OPTIONS

- 1-YEAR SPONSORSHIP OPTION (\$10,000 for a General or Education Research Grant)
- 1-YEAR SPONSORSHIP OPTION (\$2,500 for a Doctoral Research Grant)
- 1-YEAR SPONSORSHIP OPTION (\$1,000 for a Masters Research Grant)
- The research grant sponsorship contribution as designated on page one must be received by March 31st of the calendar year during which the research grant is to be awarded. This amount will be awarded to the research grant recipient.
- A research grant award in the name of the research grant sponsor will be presented at the next NATA Clinical Symposia & AT Expo.

The average fair market value calculated above must equal or exceed the minimum for full funding established by the NATA FOUNDATION Board of Directors to allow a distribution to be made from the fund in the next fiscal year. If this is not the case, income will be reinvested until this threshold is reached. Once the principal has reached \$50,000 or \$25,000, subsequent donations may be added to the principal to ensure funds are available to administer the grant in years in which the interest may not reach the amount necessary to award the grant.
