## NATA Foundation Research Grant Sponsor Options

The NATA Foundation currently offers two (2) endowment options and three (3) annual options for consideration by prospective NATA Foundation research grant sponsors. The requirements for each option are outlined below.

### FULL ENDOWMENT RESEARCH GRANT OPTION\*

- Agree to make a one-time sponsorship contribution of \$50,000 for a Doctoral Research Grant or \$25,000 for a Masters Research Grant
- Your \$50,000 or \$25,000 gift will be maintained in perpetuity (in your designated research endowment account) by the NATA Foundation.
- A \$1,000 or \$2,500 research grant (depending on designation) award will be presented annually, beginning 1 year after the endowment has been fully funded.
- Each successive annual grant award will be funded by the earnings from the balance of your one-time gift (in your designated scholarship endowment account).
- No further research grant sponsorship contributions will be required for this option.

### ANNUAL RESEARCH GRANT SPONSORSHIP OPTIONS

#### 1) 1-YEAR PROFESSIONAL LEVEL SPONSORSHIP OPTION

- \$50,000 for a General Research Grant
- \$20,000 for a New Investigator Research Grant
- Restricted RFP (amount TBD – Foundation pre-approval required)

#### 2) 1-YEAR SPONSORSHIP OPTION (\$2,500 for a Doctoral Research Grant)

#### 3) 1-YEAR SPONSORSHIP OPTION (\$1,000 for a Masters Research Grant)

Please consult with the Foundation regarding the timeline when executed agreements and funding must be received prior to first sponsored research grant being awarded.

\*Endowments:

The average fair market value calculated above must equal or exceed the minimum for full funding established by the NATA FOUNDATION Board of Directors to allow a distribution to be made from the fund in the next fiscal year. If this is not the case, income will be reinvested until this threshold is reached. Once the principal has reached \$50,000 or \$25,000, subsequent donations may be added to the principal to ensure funds are available to administer the grant in years in which the interest may not reach the amount necessary to award the grant.
